Dear Ms. McAllister-Cox,

Thank you for requesting approval of the 00 Cyclops Roulette. We have completed our review.

The 00 Cyclops Roulette is approved for use in Washington State with the following requirements:

- The Controller Unit has a network port located on it that allows access to the Network Interface Card (NIC) if a computer is plugged into it. This network port on the Controller Unit must be disabled.

Any modifications made to the 00 Cyclops Roulette, software, or associated equipment must be submitted to us for additional testing and review. We reserve the right to investigate and reevaluate the 00 Cyclops Roulette and software if we determine that such a review is required to ensure compliance.

Our testing revealed that 00 Cyclops Roulette has a protection interval of approximately 5 seconds and/or 1.5 wheel rotations. This is activated if the number of wheel rotations is less than three. The 00 Cyclops Roulette will flash the number displayed to allow for the dealer to pick up

the ball prior to recording the number. Based on this, the 00 Cyclops Roulette facilitates the results of gambling activities by electronically reading and displaying the outcome of the gambling activity by validating the spin.

It is recommended that the memory of the Cyclops Simula be cleared in the case where a ball is mistakenly read due to a bad spin. The memory must be cleared in order to ensure accurate statistical values are advertised to players.

As the manufacturer of the 00 Cyclops Roulette, Set Production manufactures the main controller, produces the operation manual, issues a warranty on the 00 Cyclops Roulette, and all upgrades and warranty protocols come from Set Production. Based on this, Set Production will require licensure as a manufacturer for further distribution of 00 Cyclops Roulette in Washington upon expiration of their Special Sales Permit.
