RE: EZ Trak Pai Gow System version 1.0

Dear Mr. Miron,

Thank you for requesting approval of the EZ Trak Pai Gow version 1.0 system in Washington State.

We are approving the EZ Trak Pai Gow version 1.0 system with the following requirements:

- 1. Prior to using the EZ Trak Pai Gow system in Washington, you must update the EZ Pai Gow game rules documenting the approved equipment to be used with the game.
- 2. The EZ Trak Pai Gow version 1.0 system can only be deployed as tested, approved and verified by the electronic signatures listed below.
- 3. Licensees and Tribal casinos must ensure the EZ Trak Pai Gow system can be viewed by surveillance as required in WAC 230-15-280 and the Tribal-State Compacts.
- 4. To ensure security and access to the system, licensees and Tribal casinos should implement internal controls/procedures and/or physical barriers to prevent unauthorized access to the USB ports on the CPU unit. These measures will prevent unauthorized access through the ability to insert a USB drive, keyboard, or mouse to access the CPU/EZ Trak system. Another option would be to disable the USB ports through the Basic Input-Output System (BIOS). This method disables the USB ports but would require the use of the PS2 connection to re-enable the USB ports if access to the system is needed later for any authorized access.

It was noted during testing that if the EZ Trak Pai Gow system was left on for long periods of time (several days), occasionally, the LCD display board would freeze up, and no controls could be utilized. If this occurs, the system must be shut down and re-started.

Any modifications made to the EZ Track Pai Gow version 1.0 system, must be submitted to us for additional testing and review prior to implementation. We reserve the right to investigate and reevaluate the EZ Trak Pai Gow system if we determine that such a review is required to ensure compliance.
