- The two PIN numbers needed to access the shuffler's configuration and setup menu via the web interface are not to be shared with non-SHFL Entertainment employees and are only to be used by SHFL Entertainment Field Technician's.
- The third PIN number which is used for settings, adjustments, and putting the unit into Verify mode, may be shared with the casino staff.

Dear Ms. Sherwood,

Thank you for requesting approval of the MD3 Shuffler with optional printer. We have completed our review.

The MD3 Shuffler with optional printer is approved for use in Washington operated only as described in the documentation you provided us in the Game Endorsement Form for New or Upgraded Equipment. The approval is contingent on the following requirements:

- Any PIN numbers needed to access the shuffler's configuration and setup menu are not to be shared with non-SHFL Entertainment employees and are only to be used by SHFL Entertainment Field Technician's.
- There can be no access to the serial port of the device while on the live floor of the casino and the software signatures of the device are checked before the shuffler is put back into play.
- The Enable Network setting in the Network Menu must be set to "Disabled" before the shuffler is put into play to ensure the device is secure and avoid any potential security risks.
- To ensure the system remains a closed system as required by WAC 230-16-151, only one external tool may be connected to the shuffler at a time. The shuffler will never be connected to any networking devices such as hubs, switches, or routers. Any external tool connected to the shuffler must have all wireless/Bluetooth functions disabled at all times during the connection.

Tribal Casino Implementation:

For Tribal Casinos, ensure internal controls are revised to include new equipment and procedures, and approved by Tribal Gaming Agency and concurred with by the Washington State Gambling Commission.
