RE: iDeal Shuffler version 3.8.024, iDeal Card Recognition 4.0.033 with iVerify v1.0.0.17

Dear Ms. Zarach,

Thank you for requesting approval of the iDeal shuffler upgrade with iVerify Display. We have completed our review.

The iDeal Single Deck Shuffler upgrade with iVerify Display is approved for use in Washington State. We are approving the iDeal Single Deck Shuffler version 3.8.024 with iVerify Display version 1.0.0.17 with the following requirements:

iDeal Single Deck Shuffler v. 3.8.024:

- The dealer must wash all new decks prior to inserting them into the iDeal Shuffler; and
- The dealer must shuffle the deck before placing the cards into the iDeal Shuffler after every hand; and
- The dealer cannot access the iDeal screen menu; only a supervisor or above should be able to access password protected areas of the screen menu.
- The Network Gaming System was disabled in the code. Therefore, this feature was not tested and is not allowed in the State.

iVerify Display v 1.0.0.17:

- Licensees, who use the iDeal with the iVerify Display, must ensure all other players at the table have set their hands before using the iVerify Display to set a player's hand "house way."
- Dealers must not access the iVerify Display to reveal the dealer "house way" until all players at the table have set their hands or had their hand set "house way".
- Licensees and Tribal casinos must ensure the iVerify Display can be viewed by surveillance as required in WAC 230-15-280 and Tribal-State Compacts.



- The iVerify v 1.0.0.17 is only approved for use with iDeal v 3.8.024 and iDeal card recognition v 4.0.033.
- The iVerify v 1.0.0.17 was submitted and tested for use with Pai Gow (public domain) and Fortune San Lo Poker. Upon submission and approval of game rules indicating the use of this equipment, the iVerify v 1.0.0.17 will be approved for Fortune Pai Gow Poker and Fortune Pai Gow Poker Progressive.

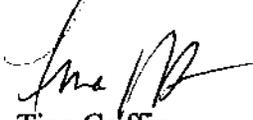
