Dear Ms. Kimball,

We have reviewed the changes made to Kings Bounty Blackjack. Based on our review of the documentation we received from SHFL Entertainment, the Washington State Gambling Commission will approve the game under the conditions listed below:

- The game shall be played and operated under the terms and conditions set forth under the "Kings Bounty Blackjack Deluxe Rules of Play" you provided on January 9, 2014, and are enclosed.

**Commercial Card Rooms**

- Commercial card room operators seeking to operate this game must first submit their internal controls and receive approval from the Commission prior to implementing.
- Manufacturers and distributors of graphic layouts and/or any other equipment associated with the game must be licensed by the state prior to the sale of the equipment.

**Tribal Casinos**

- Each Tribal Gaming Operation must request and obtain approval from their respective Tribal Gaming Agencies (TGA).
- Before TGA allows your game to operate, they will seek concurrence from our agency as well.
- In addition to your approved rules, the Tribal submission to us must include all supplemental information required by Tribal-State Compact Appendix A, Section 18.





- Manufacturers and distributors of graphic layouts and/or any other equipment associated with the game must be certified by the state and licensed by the Tribe prior to the sale of the equipment.

## Deluxe Version

*King's Bounty Deluxe is a standard house-banked blackjack game but with an optional bonus wager. All rules pertaining to standard blackjack as posted on the WSGC's website remain the same and are not altered in this game.*

### RULES AND DEALING PROCEDURES

1. Players must make a blackjack wager in order to participate in the Kings' Bounty bonus bet.
2. Casinos set the minimum and maximum bets.
3. Players make the King's Bounty bonus bet by betting in the marked area.
4. The dealer follows house procedures for blackjack.
5. When each player and the dealer have two starting cards, the dealer settles King's Bounty wagers.
  - a. Exception: If a player has two Kings of Spades and the dealer has a potential blackjack, the dealer will settle the King's Bounty bet at the end of the round. If the dealer has a blackjack, the player will not have the option of adding to their blackjack wager.
6. When players have a winning King's Bounty hand, they have a choice:
  - a. Take all the proceeds from the bonus bet down; or
  - b. Leave any portion up to all their proceeds on the King's Bounty betting spot.

7. The dealer will ask the players if they want to receive all of the proceeds from their winnings or choose to leave all or a portion of the winnings on the King's Bounty Deluxe spot. The King's Bounty Deluxe spot and Blackjack spot are considered separate wagers and are decided upon the outcome of the blackjack hand. Thus, if he eventually splits, the Player may match the entire King's Bounty Deluxe wager and blackjack wager. If he doubles down, he may match the entire King's Bounty Deluxe wager and blackjack wager (unless he chooses to 'double down for less' as per casino rules).
8. Sample payouts below:

First Two Player Cards	Pays
2 Kings of Spades + Dealer BJ	1,000 to 1
2 Kings of Spades	75 to 1
2 Suited Kings	25 to 1
2 Suited Queens, Jacks or 10s	10 to 1
Suited 20	6 to 1
2 Kings	4 to 1
Unsuited 20	2 to 1

*Operators cannot allow wagering limits to exceed the authorized limits set out in WAC 230-15-040 and WAC 230-15-140.*
