THIS MATTER came on for hearing before the undersigned Commissioners of the Washington State Gambling Commission at the Commission's regularly scheduled meeting on November 20, 2009, in Lacey, Washington, on Licensee Melissa Holven's Petition for Review. The Licensee failed to appear, but submitted a written request for a continuance that was denied by the Commission. Agency staff were represented by Assistant Attorney General H. Bruce Marvin. The Commission had before it the entire record of the proceedings before the Administrative Law Judge, as well as additional pleadings prepared for the presentation of the Petition. Following argument, and review of the record, the Commission finds that the Licensee is in Default and, further, that the record in this matter is sufficient to support the Findings of Fact, Conclusions of Law and Initial Order of the Administrative Law Judge and hereby Orders as follows:

IT IS ORDERED that the Administrative Law Judge's Findings of Fact, Conclusions of Law and Initial Order heretofore made and entered in this matter be, and the same hereby are,

AFFIRMED, and that they are incorporated into this Order by reference and adopted as the Findings of Fact, Conclusions of Law and FINAL ORDER of the Commission; and,

IT IS FURTHER ORDERED that the license to conduct gambling activities previously issued to Melissa Holven is, accordingly, HEREBY REVOKED.
