

FINAL ORDER ON

THIS MATTER came on for hearing before the undersigned Commissioners of the Washington State Gambling Commission at the Commission's regularly scheduled meeting on January 14, 2010, in Seattle, Washington, on Licensee The Club's Petition For Review. The Licensee appeared and was represented by its attorney, ~~John A. Sterbick~~ ^{Tommy Hightower} ~~MA~~ ^{MA} ~~JICE~~ ^{MA}. Agency staff were represented by Assistant Attorney General H. Bruce Marvin. The Commission had before it the entire record of the proceedings before the Administrative Law Judge, as well as additional pleadings prepared for the presentation of the Petition. Following argument, and review of the record, the Commission finds that the record in this matter is sufficient and Orders as follows:

IT IS ORDERED that the Administrative Law Judge's Findings of Fact and Conclusions of Law heretofore made and entered in this matter be, and the same hereby are, AFFIRMED, and that they are incorporated into this Order by reference and adopted as the Findings of Fact and Conclusions of Law of the Commission; and,

IT IS FURTHER ORDERED that, based on the above referenced Findings of Fact, Conclusions of Law and the record herein, the licenses to conduct gambling activities previously issued to Licensee The Club should be and, accordingly, are HEREBY REVOKED.
