
FINAL ORDER ON

THIS MATTER came on for hearing before the undersigned Commissioners of the Washington State Gambling Commission at the Commission's regularly scheduled meeting on May 14, 2010, in Pasco, Washington, on Licensee New Grove's Petition For Review. The Licensee ~~appeared through, and was represented by, its owner, James Hoa Nguyen.~~ *failed to appear.* *mk* *ADN* *MM* Agency staff were represented by Assistant Attorney General H. Bruce Marvin. The Commission had before it the entire record of the proceedings before the Administrative Law Judge, as well as additional pleadings prepared for the presentation of the Petition. Following argument, and review of the record, the Commission finds that the record in this matter is sufficient to support the Corrected Findings of Fact, Conclusions of Law and Initial Order of the Administrative Law Judge and hereby Orders as follows:


