**NOTICE OF ADMINISTRATIVE  
CHARGES AND OPPORTUNITY  
FOR AN ADJUDICATIVE  
PROCEEDING**

I.

The Washington State Gambling Commission issued Prospector's Steak & Ale, organization number 00-18214, the following licenses:

- Number 05-09911, authorizing Class "B" Punchboard Pull-Tab activity; and
- Number 65-07158, authorizing Class "D" Public Card Room activity.

The licenses expire on September 30, 2011, and were issued subject to the licensee's compliance with state gambling laws and regulations.

II.

Rick Day, Director of the Washington State Gambling Commission, charges the licensee with the following violations of the Washington State Gambling Act, 9.46 RCW, and WAC Title 230:

- 1) Prospector's Steak & Ale failed to submit its punchboard/pull-tab activity report for the third and fourth quarters of 2010. The activity report was due at our administrative office by January 30, 2011. However, as of April 18, 2011, the licensee had not submitted the activity report, in violation of WAC 230-14-284(2).
- 2) Previously, the license has failed to timely submit its punchboard/pull-tab activity reports for the following quarters:
  - The first and second quarters of 2009.
  - The first and second quarters of 2010.
- 3) In August 2009, Prospector's Steak & Ale received a written warning for failure to timely submit its first and second quarters of 2009 punchboard/pull-tab activity report.
- 4) On August 26, 2010, a Commission Special Agent (agent) issued a Notice of Violation and Settlement (NOVAS)<sup>1</sup> to the licensee for failing to timely submit its punchboard/pull-tab activity report for the first and second quarters of 2010. However, the licensee failed to pay the NOVAS,

and on January 7, 2011, the Director issued administrative charges against the licensee. The licensee failed to respond to the charges, and as a result, on April 14, 2011, the Commission issued a Default Order suspending Prospector's Steak & Ale's licenses for 30 days.

5) Prospector's Steak & Ale's repeated failure to timely submit its activity report demonstrates the licensee's willful disregard for complying with state administrative rules. Therefore, grounds exist for the suspension or revocation of Prospector's Steak & Ale's licenses to conduct gambling activities, based on RCW 9.46.075(1) and WAC 230-03-085(1), (3), and (7).

**RCW 9.46.075 Denying, suspending, or revoking a license or permit**

The Commission may deny an application, or suspend or revoke any license or permit issued by it, for any reason or reasons, it deems to be in the public interest. These reasons shall include, but not be limited to, cases wherein the applicant or licensee, or any person with any interest therein: (The following subsections apply.)

(1) Violated, failed or refused to comply with the provisions, requirements, conditions, limitations or duties imposed by chapter 9.46 RCW and any amendments thereto, or any rules adopted by the Commission pursuant thereto, or when a violation of any provision of chapter 9.46 RCW, or any Commission rule, has occurred upon any premises occupied or operated by any such person or over which he or she has substantial control.

**WAC 230-03-085 Denying, suspending, or revoking a license or permit**

We may deny, suspend, or revoke any application, license or permit, when the applicant, licensee, or anyone holding a substantial interest in the applicant's or licensee's business or organization:

(The following subsections apply.)

(1) Commits any act that constitutes grounds for denying, suspending, or revoking licenses or permits under RCW 9.46.075.

(3) Has demonstrated willful disregard for complying with ordinances, statutes, administrative rules, or court orders, whether at the local, state, or federal level.

(7) Fails to provide us with any information required under Commission rules within the time required, or, if the rule establishes no time limit, within thirty days after receiving a written request from us.

**WAC 230-14-284 Activity reports for punchboard and pull-tab licensees**

Punchboards and pull-tab licensees must submit an activity report to the Commission. Licensees must complete the report in the format we require and must:

(The following subsections apply.)

(1) Cover the periods: (a) January 1 through June 30; and (b) July 1 through December 31; and

(2) Be received at our administrative office or postmarked no later than thirty days following the end of the reporting period.

III.

Jurisdiction of this proceeding is based on 9.46 RCW, Gambling, chapter 34.05 RCW, the Administrative Procedure Act, and WAC Title 230.


The licensee will have the opportunity to have a hearing on the alleged violations.

**In order to have a hearing or discuss settlement options**, the enclosed request for hearing must be completed and returned to the Gambling Commission **within 23 days** from the date of the mailing of this notice.

Based on RCW 34.05.440, failure to return a request for hearing will result in the entry of a default order REVOKING YOUR LICENSES.


