Between 2010 and June 2013, we have received approximately 5,880 online applications totaling \$1.7 million.

2012 Statistics of Online Activity:

- **58% or 2,876 of all commercial card room employee renewals were submitted online.**
- **35% of commercial card room employees renewing online paid with ACH; remainder paid with a credit card.**
- **19% or 668 commercial card room Change of Employer applications were submitted online.**
- **Fund Raising Event application is the most frequently submitted organizational application submitted online followed by the Raffle application.**




Financial Activity Reporting:

- **All activity reports can be submitted online.**
- **For the period ending December 31, 2012, approximately 1,660 or 60% of the reports were submitted online.**


Coming in August 2013:
