# OVERVIEW

## Gambling Trends For 3rd Quarter 2013 (Does not include tribal figures.)

Overall gambling receipts in the state decreased since last quarter, and also decreased when compared with the same quarter in the prior year.

Nonprofit gross receipts decreased since prior quarter, for bingo and punchboard/pull-tabs. Gross for Raffles increased. But, raffles & smaller bingo report annually and totals can vary greatly by quarter, due in part to this seasonality.

Bingo & pull-tabs decreased, when compared with a year ago. Gross for Raffles increased. Variations occur in the number of annual reports received in any one quarter.

Commercial punchboard/pull-tab and card room gross receipts decreased since the prior quarter, and both decreased since the same quarter in the prior year.


Distribution of Activities

For 3rd Quarter 2013



By segment




By activity




Gross Receipts

The Commission continues to issue more licenses for punchboard/pull-tab than for any other activity.

Punchboard/pull-tabs produce more in gross receipts. However, card room gross receipts are greater per operator.

Commercial activities are over two-thirds of the licenses and over four-fifths of licensed gambling gross receipts.

Nonprofits generate slightly less in gross receipts from bingo, when compared to the punchboard/pull-tabs.

“Others” includes raffles and fund raising events.




## Number of Licenses For 3rd Quarters (Only includes licensees reporting activity.)









*Over four-fifths of bingo licenses are for smaller bingo operations (classes A-E).*

*Bingo operations that are mid-size (annual receipts of over \$650,000 but less than \$5,000,000) brought in over three-fourths of the total bingo gross receipts.*

*The mid-size bingo (class F-J) operators also reported nearly half of the net income.*

*While these top 10 represent only 15.6% of the bingo licensees reporting this quarter, they represent 78.6% of the total gross receipts, and 79.9% of total prizes paid out.*







- (3) Reported activity includes only those card rooms licensed to collect fees or operate house-banked card games (Commercial classes B, C, E, F, or house-banked licenses). Excludes small nonprofit card rooms, if any (Classes A, B or C).
