Thank you for requesting approval of Cammegh Mercury 360 Wheel with Halo Band (#3112) and the Cammegh Billboard Display v 2.1 (#3113). We have completed our review. The Cammegh Mercury 360 Wheel with Halo Band and Cammegh Billboard Display v. 2.1 is approved for use in Washington State Tribal Casinos.

Approval of the Cammegh Mercury 360 Wheel with Halo Band and Cammegh Billboard Display v. 2.1 are contingent on the following requirements:

## Manufacturer Requirements:

- Provide information to the tribal casino to keep the rotor speed between 10-30rpm for accurate display and recording of ball drops/outcomes.
- The keyboard and mouse must be disconnected from the billboard controller during play.
- Ensure all unused open ports on the Break Out Box (BOB) and CPC box are disabled or blocked from use.
- The Spread Bet side wager is not approved for use at this time.

## Tribal Casino Implementation:

• Ensure internal controls and or game rules are revised to include new equipment, and procedures and are approved by the Tribal Gaming Agency and concurred with by the Washington State Gambling Commission.

• Ensure game rules are revised to include games approved for use with the Cammegh Mercury 360 Wheel and Billboard Display to be offered and are approved by the Tribal Gaming Agency and concurred with by the Washington State Gambling Commission.
