# Minimum Requirements Approved Locations Commercial Amusement Games

### WAC 230-06-065 Display of Licenses

All licenses or permits granted by the Commission shall be prominently displayed at all times upon the licensed premises in such position as they may be observed by persons participating in gambling activities on the licensed premises.

#### WAC 230-13-010 Approval of New Amusement Games

- Operators may introduce new games that meet the standards of an authorized group without approval as long as they provide their assigned agent and description, the rules of play and the group number with an explanation of why that group number was chosen <u>at</u> <u>least 60 days before introducing the game.</u>
- If the agent notifies the operator that the proposed game does not meet the standards or otherwise violates gambling laws or rules, the operator:
  - a. May not introduce the game; and
  - b. If it has already been introduced, must remove it from play

# **Operation Restrictions**

- The operation must be closely monitored and controlled to ensure all games are operated in accordance with all provisions of the WAC title and the players are protected from fraud and game manipulation. All games and machines must be maintained in proper condition to ensure operation is as approved in WAC 230-13-005.
- 2. An adult must supervise all locations where school-aged minors are allowed to play during all hours of operation. (A school-aged minor is anyone who is at least 6, but not yet 18 years old.)
  - a. In regional shopping centers, movie theaters, bowling alleys, miniature golf course facilities, skating facilities, family sports complex, amusement centers, restaurants or grocery stores, the adult supervisor must ensure that school-aged minors are prohibited from playing amusement games during school hours and after 10:00 p.m. on any day.
  - In regional shopping malls, the school-aged minors must also be prohibited from entry into the licensed amusement game locations after the normal shopping area closing hours on Sunday through Thursday.

# WAC 230-13-135 Wager and Prize Limitations

In locations defined in 2(a) above where school-aged minors are allowed to play, a single prize must be limited to an operator cost of \$500 and the maximum single wager allowed is three dollars and fifty cents.

#### WAC 230-13-120 Rules to be Posted

- 1. Fees charged for playing.
- 2. Rules by which game is to be played.
- 3. Prizes or number of tickets to be won.
- 4. Any variation in the size or weight of objects utilized in the game that is not readily visible to the player. Example: Milk Bottle Toss (must have the weight of each bottle displayed.)
- 5. The name of the operator and an assigned concession number.
- 6. Booth numbering, if applicable.
- 7. Amusement game group number.

## WAC 230-03-085 Failure to Make Gambling Tax Payments

Licensees may have their license suspended or revoked for failure to pay local taxes. Approved Location operators should refer to their contract with the equipment provider and local ordinances regarding who is responsible for payment of local taxes.
