Commercial Card Rooms

- Commercial card room operators seeking to operate this game must first submit their internal controls and receive approval from the Commission prior to implementing.
- Manufacturers and distributors of graphic layouts and/or any other equipment associated with the game must be licensed by the state prior to the sale of the equipment.

Tribal Casinos

- Each Tribal Gaming Operation must request and obtain approval from their respective Tribal Gaming Agencies (TGA).
- Before TGA allows your game to operate, they will seek concurrence from our agency as well.
- In addition to your approved rules, the Tribal submission to us must include all supplemental information required by Tribal-State Compact Appendix A, Section 18.

with the game must be certified by the state and licensed by the Tribe prior to the sale of
the equipment.

W/5 Card Poker STAX

Rules of Play

Criss Cross Poker is a poker game played using a standard 52 card deck. To begin, each player must place two ante bets of equal value, with one corresponding to the across hand, and one corresponding to the down hand. The player may also place an optional 5 Card Bonus bet.

- (a) Dealer then deals five community cards face down in such a way that they form a cross. Each player is then dealt two cards face down. Players may examine their own cards.
- (b) The dealer shall offer each player the option to either make an "Across" bet or forfeit their ante wagers. The "Across" bet must be one to three times the amount of their ante bet. After each player has placed the "Across" bet the dealer will turn over the two outside cards on the horizontal line of the cross.
- (c) The dealer shall offer each player the option to either make the "Down" bet or forfeit all previous wagers. The "Down" bet must be one to three times the amount of their ante bet.

 After each player has placed the "Down" bet the dealer will turn over the two outside cards on the vertical line of the cross.
- (d) The dealer shall offer each player the option to either make the "Middle" bet or forfeit all previous wagers. The "Middle" bet must be one to three times the amount of their ante bet. After each player has placed the "Middle" bet the dealer will turn over the middle card on the cross.
- (e) The dealer shall then reveal the player's cards. The player uses their two cards plus the three cards on the horizontal line of the cross to form an Across hand and uses their two cards plus the three cards on the vertical line of the cross to form a Down hand.
- (f) Winning Across and Down hands are paid per the pay table listed in Table 1. The Middle bet is paid if either the Across or Down bet qualify as a win and is paid at the odds of the highest ranking hand. If the Across bet is a push and the Down bet loses the Middle bet is also a push, or if the Across bet loses and the Down bet is a push the Middle bet is also a push. If both the Across bet and Down bet push the Middle bet also is a push. The Middle bet only loses if both the Across and Down bets lose.

- (g) The two ante bets are paid even money on qualifying hands for their respective hand. A qualifying hand is defined as any of the paying bets (pair of Jacks or Better). Pair of 6s through 10s result in a push, and all other outcomes forfeit the ante bets.
- (h) The 5 Card Bonus bet is resolved immediately at the end of the game, regardless of player fold decisions, and is evaluated based on the five community cards. The pay table for the 5 Card Bonus bet is listed in Table 2.
- (i) Operators cannot allow wagering limits to exceed the authorized limits set out in WAC 230-15-040 and WAC 230-15-140.
- (j) If the Optional 5 Card Poker STAX Progressive is offered, the optional 5 Card Poker STAX Progressive wager wins if the Player's two hole cards along with either "ACROSS" or "DOWN" community cards for the better five-card hand are any of the following, regardless of player fold decisions:
 - a. Royal Flush Progressive (Diamonds)
 - b. Royal Flush Progressive (any Suite other than Diamonds)
 - c. Straight Flush Progressive
 - d. Four of a Kind Progressive
 - e. Full-House Progressive optioni. Refer to STAX Progressive paytables for payout scale
 - f. Flush
 - g. Straight
 - h. Three of a Kind
 - i. Two Pair
 - j. The STAX progressive system is configured for a \$1.00 or \$5.00 progressive wager.
 - k. All static pays will be paid from the chip tray. Progressive's pays are paid from the displayed metered prizes.
 - I. When using the STAX system, upon completion of the round the dealer will touch "End Round" on the dealer terminal. This will start the next round.
 - m. See STAX Jackpot approval process for additional payout procedures.
 - n. Progressive jackpot accumulation and prizes must follow WAC 230-15-680 and WAC230-15-720 and must be identified in the operator's internal controls.
 - o. Criss Cross Poker must use the AGS STAX Table Game Progressive System v1.0.1 or higher hardware and software.





STA JACKPOT APPROVAL PROCESS

- During normal play, a hand which achieves a payout on the paytable is identified, and the dealer touches the seat of the player on the Dealer Terminal.
- (Note: hands shown on images are just examples) After touching the seat number, the hand achieved is selected, OR "None" is selected to undo the erroneous process if a hand was not achieved.


Touching "None" would be the first chance for undoing/erasing an incorrect entry.

If the hand is selected, it will then display on the main screen with the "Pending Jackpot" button. The amount is not shown at this point because it is not yet authorized to be paid, but the hand achieved does now display under the player's seat number.

> Touch "Pending Jackpot" to proceed with the selected hand.

A second confirmation screen appears. Touch "Pay Jackpot" to proceed, OR touch "Cancel Jackpot" if the jackpot should not be awarded.

> The Cancel Jackpot is your opportunity to undo the jackpot process if it is entered improperty.





STA JACKPOT APPROVAL PROCESS

If "Pay Jackpot" is touched, the hand should be confirmed as valid and at this point, the entry of an Authorization Code is required.

> ESC to exit the entry of a code is the third and final opportunity to avoid awarding an improper jackpot award; entering the code verifies it was correctly awarded.

At this point, the amount of the win is now shown. Up until this point it is not shown because it was not yet validated to be a proper jackpot without the prior steps.

Touch "Pay Jackpot" to award the amount.

The winning amount is now also shown/ communicated to the player(s) at the table on the table sign.

> Leave the sign and Dealer Terminal in this state until the player's amount is paid according to your ICs.

Final notes on an incorrectly paid jackpot:

If all three points of exiting the jackpot process are bypassed, and it is still determined later that the meter amount needs to be put back to its previous position, this can be accomplished with the PC that administers the game settings.
