Dear Ms. Kastner,

Thank you for requesting approval to market the card game "Bet The Bust" to Washington State commercial card rooms and Tribal casinos. Based on our review of the documentation we received from Tech Art Manufacturing Inc., the Washington State Gambling Commission will approve the game under the conditions listed below:

Commercial Card Rooms

- The game shall be played and operated under the terms and conditions set forth under the "Bet The Bust – Rules of Play" you provided.
- Commercial card room operators seeking to operate this game must first submit their internal controls and receive approval from the Commission prior to implementing.
- Manufacturers and distributors of graphic layouts and/or any other equipment associated with the game must be licensed by the state prior to the sale of the equipment.

Tribal Casinos

- The game shall be played and operated under the terms and conditions set forth under the "Bet The Bust – Rules of Play" you provided.
- Each Tribal Gaming Operation must request and obtain approval from their respective Tribal Gaming Agencies (TGA).
- Before TGA allows your game to operate, they will seek concurrence from our agency as well.



- In addition to your approved rules, the Tribal submission to us must include all supplemental information required by Tribal-State Compact Appendix A, Section 18.
- Manufacturers and distributors of graphic layouts and/or any other equipment associated with the game must be certified by the state and licensed by the Tribe prior to the sale of the equipment.

Please be advised that the Financial Investigations Unit is currently reviewing your game application for any new substantial interest holders, as defined by WAC 230-03-045, related to this game and may be contacting you.

Furthermore, any modifications to this game may affect this approval. Contact the Commission should you contemplate modifications. If you have any questions on commercial implementation, please contact Jess Lohse at (425) 277-7017. If you have any questions on Tribal implementation, please contact Kelly Main at (206) 423-4260.

Advantage Play Analysis of "Bet the Bust" **Blackjack** Side Bet

Rules for Bet the Bust 21

Bet the Bust is standard house banked blackjack but with an optional bonus wager. All rules pertaining to standard blackjack as posted on the WSCG's website remain the same and are not altered in this game"

1. **Bet the Bust** is a blackjack side bet, available for blackjack dealt from 1, 2, 6 or 8 decks.
2. The player must place a blackjack bet in order to play the **Bet the Bust** side bet.
3. Wagers on **Bet the Bust** are placed after the dealer and all players have received their cards and the dealer has delivered his up card.
4. In the case that the dealer's up card is either a Ten, Jack, Queen, King or Ace, the **Bet the Bust** wager is allowed after the dealer's hand has been checked to see if it is a blackjack.
5. After viewing the up card of the dealer, if the dealer does not have blackjack, the player can choose to participate in the **Bet the Bust** side bet.
6. If a player chooses to participate, an additional **Bet the Bust** wager is placed in the designated area on the layout.
7. The **Bet the Bust** side bet is resolved based on the final result of the dealer's hand.
8. The player wins the **Bet the Bust** side bet if one or more players remain in the hand and the dealer busts his hand. The wager is then paid according to the designated pay table for the specified rules of the game and dealer up card. See figure 1.
9. The **Bet the Bust** side bet is a push if no players remain in the hand to compete against the dealer after all players resolve their hands. In this case the dealer does not draw cards.
10. The player loses the **Bet the Bust** side bet if one or more players remain in the hand and the dealer makes his hand (achieves a total of 17, 18, 19, 20 or 21).

11. The player is paid according to the pay table given in figure 1. We denote the rule where the dealer hits on soft-17 by 1117. We denote the rule where the dealer stands on soft-17 by S17. Note that the pay tables are the same for H-17 and S-17 with the exception of the pay for an Ace up card.

Rules for Bet the Bust 21

Bet the Bust is standard house banked blackjack but with an optional bonus wager. All rules pertaining to standard blackjack as posted on the WSCG's website remain the same and are not altered in this game"

1. Bet the Bust is a blackjack bonus wager, available for blackjack dealt from 1, 2, 6 or 8 decks.
2. The player must place a blackjack bet in order to play the Bet the Bust bonus wager.
3. Wagers on Bet the Bust are placed after the dealer and all players have received their cards and the dealer has delivered his up card.
4. In the case that the dealer's up card is either a Ten, Jack, Queen, King or Ace, the Bet the Bust wager is allowed after the dealer's hand has been checked to see if it is a blackjack.
5. After viewing the up card of the dealer, if the dealer does not have blackjack, the player can choose to participate in the Bet the Bust bonus wager.
6. If a player chooses to participate, an additional Bet the Bust wager is placed in the designated area on the layout.
7. The Bet the Bust bonus wager is resolved based on the final result of the dealer's hand.
8. The player wins the Bet the Bust bonus wager if one or more players remain in the hand and the dealer busts his hand. The wager is then paid according, to the designated pay table for the specified rules of the game and dealer up card. See figure 1.
9. The Bet the Bust bonus wager is a push if no players remain in the hand to compete against the dealer after all players resolve their hands. In this case the dealer does not draw cards.
10. The player loses the Bet the Bust bonus wager if one or more players remain in 'the hand and the dealer makes his hand (achieves a total of 17, 18, 19, 20 or 21).
11. The Bet the Bust wager will win if the dealer's hand busts and the players hand does not exceed a 28 or the players hand does not result in a 28.

12. The player is paid according to the pay table given in figure 1. We denote the rule where the dealer hits on soft-17 by 1117. We denote the rule where the dealer stands on soft-17 by S17. Note that the pay tables are the same for H-17 and S-17 with the exception of the pay for an Ace up card.
