Dear Mr. Clements,

Thank you for requesting approval to market the card game “Dai Bacc” to Washington State commercial card rooms and Tribal casinos. Based on our review of the documentation we received from AGS, the Washington State Gambling Commission will approve the game under the conditions listed below:

Commercial Card Rooms

- The game shall be played and operated under the terms and conditions set forth under the “Dai Bacc – Rules of Play” you provided and are enclosed.
- Commercial card room operators seeking to operate this game must first submit their internal controls and receive approval from the Commission prior to implementing.
- Manufacturers and distributors of graphic layouts and/or any other equipment associated with the game must be licensed by the state prior to the sale of the equipment.

Tribal Casinos

- The game shall be played and operated under the terms and conditions set forth under the “Dai Bacc– Rules of Play” you provided and are enclosed.
- Each Tribal Gaming Operation must request and obtain approval from their respective Tribal Gaming Agencies (TGA).
- Before TGA allows your game to operate, they will seek concurrence from our agency as well.




- In addition to your approved rules, the Tribal submission to us must include all supplemental information required by Tribal-State Compact Appendix A, Section 18.
- Manufacturers and distributors of graphic layouts and/or any other equipment associated with the game must be certified by the state and licensed by the Tribe prior to the sale of the equipment.

Please be advised that the Financial Investigations Unit is currently reviewing your game application for any new substantial interest holders, as defined by WAC 230-03-045, related to this game and may be contacting you.

Furthermore, any modifications to this game may affect this approval. Contact the Commission should you contemplate modifications. Introduction:

Dai Bacc plays the same way as regular Mini-Baccarat except that it replaces the taking of commission on every winning Bank wager by “barring” one specific winning Bank hand; a 3 card total of 7 points. All rules pertaining to Mini-Baccarat as posted on the WSGC’s website remain the same and are not altered in this game. The three optional Dai Baccarat bonus bets offered are: an **Ox 6 Bonus** that pays when the Player wins with a three-card 6, a **Tiger 7 Bonus** that pays when the Banker wins with a three-card 7 and a **Kill Bet** that wins when the Player gets a three-card 6 and loses or ties; or, when the Banker gets a three-card 7 and loses or ties.

Dealing Procedures and Round of Play:

1. Each player will place their bets on either Player or Banker. Regardless of whether a player placed a wager on the Player line or the Banker line, that player may place a wager on any or all Bonus Bets.
 - a. Operators cannot allow wagering limits to exceed the authorized limits set out in WAC 230-15-040 and WAC 230-15-140.
 - b. Players are limited to wagering on a maximum of four games. Card room operators are required to post on the layout or on a placard at the table that players are limited to wagering on a maximum of four games.
2. Once all wagers are placed, the house dealer deals one card to the right and one card to the left, one by one in rotation, until each hand has a total of two cards each. All cards are dealt face-down.
3. The hand is then completed following standard Mini-Baccarat drawing rules for Player and Banker.
4. After the Mini-Baccarat hand is finished, each bet is resolved.
5. Winning Player or Banker bets are paid even money. Losing bets are taken.
6. No commission is taken on winning Banker bets. If the Banker wins with a three-card draw to 7 then all Banker bets push.
7. When the Banker and Player hand tie both bets push.

8. Tiger 7 Bonus Bet is paid when the Banker wins with a three-card 7.
9. Ox 6 Bonus Bet wins when the Player wins with a three-card 6.
10. The Kill bet wins in two different scenarios:
 - a. When the Banker loses or ties with a three-card 7
 - b. When the Player loses or ties with a three-card 6

When Player wins with a three-card 6


Tiger Bonus: Pays 40 to 1



DAI BACC

Dai Bacc is an exciting commission free Mini-Baccarat game that lets players make high paying bonus bets on the Player hand, Banker hand and on the “Kill Bet” that allows players to win even if they’ve lost their main bets.

HOW TO PLAY:

- Each player will place their bets on either Player or Banker and additionally any or all bonus bets. Player or Banker bets may or may not be mandatory. See house rules.
- Dealer will deal Player and Banker hands and hit according to traditional Mini-Baccarat hitting rules. Whichever hand ends up being closer to 9 following Mini-Baccarat counting rules wins, and the bet is paid even money.
- When the Banker wins with a 3-Card 7, the Banker bet pushes.

BETS:

Tiger 7: Wins 40-1 when the Banker hand has a 3-card total of 7 and wins.

Ox 6: Wins 40-1 when the Player has a 3-card 6 total and wins.

Kill Bonus: Two ways to win 30-1!

- When the Tiger 7 bet loses with a three-card Banker 7
- When the Ox 6 bet loses with a three-card Player 6

All Bonus Bets lose in a tie except the Kill bet which wins in these scenarios:

- Both Player and banker hands tie with 3-card totals of 6 -or- 7
- The Player’s three-card 6 ties the Banker’s two-card 6
- The Player’s two-card 7 ties the Banker’s three-card 7
