RE: Galaxy Gaming Andromeda Bonus Jackpot System Stage 5.1 – Submission #2154

Dear Ms. Huysmans,

Thank you for requesting approval of the Andromeda Bonus Jackpot System (BJS) Stage 5.1. We have completed our review.

The Andromeda BJS Stage 5.1 system may be operated as a bonus jackpot system or a real-time progressive system and is approved for use in Washington State. The approval is contingent on the following requirements:

Manufacturer Requirements:

- If the system is operated as a progressive system and is used to connect different card games on multiple tables to one progressive jackpot, the system must comply with WAC 230-15-685.
- You must update your game rules for card games that will use the Andromeda BJS Stage 5.1 prior to installing the equipment in Washington.
- Only licensees or Tribal casinos operating the system shall have access to the system to make changes to the Table Vision display (posting and/or choosing paytables or posting the current jackpot amount).
- Browser auto complete for user name and passwords must be disabled by Galaxy. For example, Internet Explorer auto complete can be disabled in Windows registry settings. As with wireless functionality, non-Administrator user accounts must not have the capability to modify auto-complete settings.



- To make sure the system remains a closed system, no outside network connections are allowed to be connected to the Galaxy system. Also, any devices connected to the Galaxy system must have all wireless/Bluetooth settings disabled. Casino user accounts and accounts used by Galaxy technicians may not have permissions to change wireless connection settings on devices which connect to the Galaxy system. Galaxy must ensure that only the highest level Administrator account has these permissions and that only select Galaxy personnel have access to this account.
- Locally disable the Remote Desktop and Wireless services installed on the Pit/Site Controller and/or any laptop or computer connected to the system.
- Notification to the Washington State Gambling Commission must be made prior to the first installation in Washington and each installation thereafter so arrangements may be made for Agent inspection/review. Please provide a list to include specific locations, dates and times this system will be installed at least 10 business days prior to installation. Send the list to Sonja Dolson at sonja.dolson@wsgc.wa.gov.

Requirements for House-Banked Card Game Licensees:

- After installation of the system, House-Banked Card Room (HB) licensees must ensure that wireless services are disabled on any laptop or computer connected to the system.
- You must follow all WAC rules when using this equipment.
- Licensees must ensure primary jackpot cap amounts and procedures for paying out jackpots when multiple jackpots are hit at the same time are included in their internal controls.
- Licensees must ensure chips are placed on the center of the sensor to ensure all wagers are accurately recorded.
- When using a progressive jackpot you must require a specific wagering limit on the progressive wager (For example all progressive wagers must be \$1) to ensure all funds are accounted for.

Tribal Casino Implementation:

- Ensure that wireless services are disabled on any laptop or computer connected to the system.
- For Tribal Casinos, ensure internal controls are revised to include new equipment and procedures, and approved by Tribal Gaming Agency and concurred with by Washington State Gambling Commission.

- When using a progressive jackpot we suggest you require a specific wagering limit on the progressive wager (For example all progressive wagers must be \$1) to ensure all funds are accounted for.
