The Washington State Gambling Commission (Gambling Commission) through David Trujillo, Director, and Licensee Genesis Gaming Solutions, Inc., through its President Randy Knust, and its attorney, Ron Gorsche, enter into this stipulation and settlement agreement for Case Number 2017-00899.

**I. INTRODUCTION**

1. The Washington State Gambling Commission (Commission) issued Licensee Genesis Gaming Solutions, Inc., gambling license No. 20-000234, authorizing Class "B" Manufacturer Activity, in the State of Washington. This license expires on December 31, 2018.

2. On September 27, 2017, the Commission issued administrative charges against the Licensee in the above-reference case number.

3. The Commission alleges that in 2017, Licensee operated unapproved gambling equipment in the State of Washington, in violation of WAC 230-06-050(6), WAC 230-03-200(4)(a), WAC 230-03-085(1), (3), and (8)(a), and RCW 9.46.075 (1), as well as Tribal-State Compact, Section V.C.



- 1 a. \$15,000.00 monetary penalty, which includes investigative costs, to be paid in  
2 two equal payments of \$7,500.00;
- 3 i. The first \$7,500.00 payment shall be received by the Commission by May  
4 1, 2018;
- 5 ii. The second \$7,500.00 payment shall be received by the Commission by  
6 June 1, 2018.

16 9. The original signed agreement shall be received by the Commission by April 16,  
17 2018.

18 10. In the event that the Licensee does not make full and timely payment of the  
19 monetary penalty as required in Section II, Paragraph 8, then the Licensee shall serve the vacated  
20 twenty (20) suspension days, the dates and times of which shall be set by the Commission.

21 11. The parties agree that the violations as set forth herein will not affect the current  
22 settlement agreement in Case Number CR 2015-01595.


23 12. The parties agree that the Director of the Washington State Gambling  
24 Commission, pursuant to this Settlement, has sole discretion to determine whether the Licensee  
25 has violated any term of this Settlement.

26 13. In the event the Director determines a violation of this settlement agreement has  
occurred, the parties agree that the Director may suspend the license(s) issued to GENESIS


1 | GAMING SOLUTIONS, INC., by mailing or delivering a notice of the suspension and/or
