The Washington State Gambling Commission represented by its attorneys, ROBERT W. FERGUSON, Attorney General, KELLEN WRIGHT, Assistant Attorney General, and its Director, DAVID TRUJILLO, and the Licensee, GASLIGHT BAR & GRILL, represented by KEITH MYERS, hereby enter into this stipulation and settlement agreement for Case Number CR 2019-01151.

I. INTRODUCTION

In the above-referenced case, the Washington State Gambling Commission issued a Notice of Administrative Charges dated July 23, 2019 alleging that the Licensee failed to timely file a quarterly license report and to pay any quarterly license fee along with associated costs. This conduct violated WAC 230-05-124 and WAC 230-05-132(1). The Gambling Commission Staff determined that this conduct warranted revocation of the Licensee's gambling license, No. 05-21367, under RCW 9.46.075(1) and WAC 230-03-085(1) and (5).

II. AGREEMENT OF THE PARTIES

The Gambling Commission and the Licensee agree to the following:

1. The Washington State Gambling Commission and the Licensee enter into this agreement to avoid the time and expense of further litigation.


2. The Licensee explicitly waives the right of further administrative review of all matters related to the above-referenced Administrative Charges.

3. The Licensee has filed the required reports and paid the required fees and penalties in full. Therefore, the Gambling Commission agrees to withdraw the Notice of Administrative Charges.

4. The Licensee acknowledges and agrees that, while it is licensed, it will timely file quarterly reports and timely pay any necessary license fees. The Licensee understands that these reports must be timely filed even if the Licensee is not operating under the license and no license fee is due. The Licensee further acknowledges and agrees that the failure to timely file these reports, or to pay any applicable fees, will subject the Licensee's gambling license, No. 05-21367, to revocation, as well as incur additional late filing fees.


5. This agreement constitutes the final written expression of all the terms of this agreement and is a complete and exclusive statement of these terms.
